ROGUES AND HEROES GALLERY

Guildford has the dubious honour of being the place where a crime resulted in the first death sentence in the Swan River Colony.

Richard Reilly arrived in the Colony in 1836, and was employed by James Stokes of Guildford as an agent for the sale of stores. On 10th October 1837 Stokes was informed his house, rented out to Reilly had burnt down and all his property destroyed.

Reilly told Stokes he had lost all his possessions, and some pieces of a melted substance that looked like silver. When questioned about missing sovereigns, he firmly denied having any. Then he changed his story, saying he had saved some sovereigns during his escape from the burning house. He threw them on the table, saying 'here they are Sir'. He was quickly arrested and charged with arson.

At his trial before Magistrate W.H. Mackie, witnesses recalled seeing him acting suspiciously on the night of the fire, crying he was ruined, and warning bystanders not to go in as gunpowder was in the house. Witness Mrs. Turner, a Perth storekeeper recalled hearing about the Guildford fire. Shortly afterwards, Reilly had called to pay back five pounds he owed her. Her evidence proved Reilly's alibi false.

He was committed for trial in 1838, charged with intent to defraud and injure Stokes, the complainant. Reilly was subsequently sentenced to hang. This was commuted to 11 years transportation to Van Diemen's Land, where the most hardened criminals were kept.
